IMPORTANT NOTICE

To: Retiree Participants in the TCU-LAMTA Health and Welfare Fund
From: Administrative Office
Re: **Mandatory Retiree Dependent Re-Enrollment – January 2026**

The TCU-LAMTA Board of Trustees has directed the Administrative Office to conduct a complete re-enrollment of all Retiree dependents.

As part of this process, the Administrative Office must verify the eligibility of all Retiree's enrolled dependents covered under the TCU-LAMTA Health & Welfare Fund. To complete this verification, the Fund **requires that you submit documentation verifying dependents you currently have enrolled.**

Please note that the following documents must be provided to confirm eligibility:

Spouse:

- A copy of your marriage certificate.

Biological or Adopted Children Under Age 26:

- A copy of the child's birth certificate **or** adoption paperwork showing you as the parent.

Stepchildren Under Age 26:

- A copy of your marriage certificate (to the child's parent), **and**
- A copy of the stepchild's birth certificate.

Children for Whom You Are the Legal Guardian:

- A copy of the court order establishing legal guardianship, placement, or custody.

If the required documentation is not received by February 27, 2026, coverage for your dependents will be terminated effective March 1, 2026.
